Amidst a year of continued economic challenge for the country, ACCION achieved several milestones in 2010 that reflect a powerful belief in the ability of entrepreneurs to create new opportunity, jobs and prosperity. We made a loan to our 3,000th client. We reached \$30 million in loans made since 1994. We completed a highly successful annual fundraising campaign. And in the fall of 2010, ACCION moved into its new regional headquarters in the historic Sawmill neighborhood of Albuquerque—a permanent home for entrepreneurs across the region to find the business financing and support they need. We are deeply grateful to the many donors whose support allowed ACCION to move into this building mortgage-free.

ACCION's loans have now touched over 255 communities in New Mexico, Arizona and Colorado, financing the ability of our clients to create or sustain over 5,000 jobs across the region during our 17 years of operation. But the real story is not the sum of the numbers, it is the collective stories of the individual entrepreneurs whose lives have been touched and changed with ACCION's help. These individuals include an environmentally-minded entrepreneur, a long-time restaurateur, a concrete-scanning service provider who happens to be our 3,000th client, and our cover subjects, Sharon Ricks and her husband Alfonzo Ricks. When an injury prevented her from continuing with her job, Sharon didn't see it as a setback. She saw an opportunity to start a business that could thrive during difficult times—a dollar store. After combining retirement savings with an ACCION loan, Sharon now operates S & B Dollar Store Plus in Mesa, Arizona and serves a loyal customer base.

Reflecting on my two-year term as chairman, I believe the essence of ACCION is its focus on the individual client; its support of each entrepreneur in the fulfillment of their business goals and personal dreams. Whether it is a client, a donor, a bank partner or a government official, ACCION has a deep respect for the power of each and every individual to make our community better.

As always, thank you for your continuing support of ACCION, and in turn, the individuals ACCION supports—the courageous entrepreneurs who are shaping a new paradigm of hope for our region and country.

JOHN-PAUL MAXFIELD:

Bringing Ecology and Economics Together

John-Paul Maxfield is one of the new faces of entrepreneurship across Colorado, a state where youth and environmental consciousness are combining to create one of the next economic frontiers

Like so many other individuals in the current economy, John-Paul turned to entrepreneurship after losing a job. He decided the time was right to pursue a basic and bold business idea he was passionate about – bringing ecology and economics together to make money from the waste that others toss aside while building a more sustainable agricultural system. In charting this course for his future, John-Paul was also honoring his family's agricultural roots.

With not much more than a great idea, a bit of savings and boundless entrepreneurial passion, John-Paul launched Waste Farmers, which turns food waste and other organic material from restaurants, hotels, schools, and the agricultural sector in the Denver metro area into nutrients for soil enhancement and high-quality local food production. The aim is to reduce those businesses' waste removal costs while providing Waste Farmers with the raw material to produce organic soil amendments and produce to sell.

John-Paul's business idea has quickly caught on. To gather organic waste from its growing client base, Waste Farmers soon needed a recycling truck. John-Paul approached area banks for a loan, but his business, which was nine-months old at the time, did Then, the Denver Chamber of Commerce put him in touch with ACCION. ACCION provided John-Paul with a loan to finance the truck, now known as Bertha



Bertha runs on biodiesel made from used cooking oil from Waste Farmers' restaurant clients and has made tremendous growth possible—sales for the first half of 2011 are up 229% from the same period in 2010. Now the owner of a business that supports six jobs, John-Paul says ACCION's belief in his ability to succeed gave him "an opportunity to pursue the American Dream."

Seeking Out Opportunities from the Economic Downturn

Lance Jehn is one of the many entrepreneurs across Arizona, a state hard-hit by the economic downturn, who is working undauntedly to create new sources of commerce.

As new construction slowed across the Phoenix area. Lance noted that increased activity in the renovation and remodeling of large existing buildings required concrete scanning. Already the owner of a masonry company, Lance learned more about concrete scanning and decided to launch Encompass Inspections, a new venture providing groundpenetrating radar services to the construction industry.





Lance approached a local bank for a startup loan and they referred him to ACCION. "I had enough cash in the bank to purchase the equipment," said Lance, "but I wanted a loan to protect my cash position, build business credit, and have peace of mind that I still had money in the bank." Lance found the loan he sought at ACCION and Encompass Inspections became the 3,000th business to be financed by the organization. The young business is doing well—Lance's sales projections for 2011 were realized by mid-year and he is making plans to bring a third employee on board before the end of the year.

Lance's motivation is simple and powerful, "I want to provide for my family. I launched the masonry company when my daughter turned one. Now, with my second business, I want to earn the ability to spend more time

YASHODA NAIDOO:

Giving Back to the Community and to ACCION

In addition to generating needed economic activity and employment through their businesses, more than 100 of ACCION's clients have chosen to make charitable contributions to the organization to provide a hand up to other entrepreneurs. Established restaurateur Yashoda Naidoo exemplifies the powerful philanthropic footprint ACCION's client businesses are creating through their success.

Inspired to recreate her favorite childhood dishes from India, Yashoda decided to guit her job as a certified public accountant in 2000 and open an Ayurvedic food delivery service out of her kitchen in Albuquerque. Ayurvedic cuisine is based on the principles of Ayurveda, the traditional Hindu science of health and medicine. As her reputation grew, Yashoda needed to open a restaurant to keep up with demand

With her mission statement and target customers written on a napkin, Yashoda approached ACCION for a loan to open a restaurant.

After a little refinement to her business plan, ACCION provided Yashoda with a loan for \$20,000 to lease and renovate space to open her first restaurant. Today, Yashoda owns and operates three Annapurna's World Vegetarian Café restaurants, including one in Santa Fe and a recently opened second restaurant in Albuquerque. She has built ACCION IS A PLACE WHERE SUCCESS IS AVAILABLE TO ANYONE a business that employs 45 and had sales of \$1.5 million in 2010.

From this success, Yashoda has chosen to commit over \$15,000 in charitable contributions to ACCION so that other entrepreneurs can pursue their passion to create income, jobs and hope.

Yashoda is also a volunteer ACCION mentor, offering her guidance and support to other business owners. Discussing the impetus for her gifts to ACCION, Yashoda says, "ACCION is a place where success is available to anyone with the passion, commitment and character to realize it. ACCION is the window through which entrepreneurs can envision a future of prosperity, regardless of our stations in life."


